- \$72.00** Entries for all 4 trials in an additional class with the same dog.
- \$5.00** Exhibition Only
- \$10.50** TCN Fee for EACH TRIAL. This is only paid if the entered dog is eligible for but does not possess individual registration with the Canadian Kennel Club. A Temporary Competition Number is also required for entry. See CKC.ca for details and application form

The entry of a dog at a trial must be accompanied by the entry fee. Conditional entries or entries accompanied by post-dated cheques will not be accepted.

The club must reject an incomplete entry form and promptly return it to whoever submitted it, be it the owner, lessee, or authorized agent.

Tendering of a dishonoured cheque in payment of entry fees shall be considered non-payment and is an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club.

Rules & Regulations

It is the responsibility of each competitor to be familiar with and abide by the Canadian Kennel Club Obedience Trial Rules and Regulations, effective January 1, 2021, including the rule changes due to Covid-19. Both can be found on the CKC website, WWW.CKC.ca

Discipline: Forbidden Plateau Obedience & Tracking Club reserves the right to remove any person from these trials. The Trial Chair shall have full control of this event which will be governed by the Canadian Kennel Club rules. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a trial held under the CKC Obedience Trial Rules and Regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Females in Season: When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10-day period preceding the trial must reach the Trial Secretary on or before the date of the Trial. The entry fee, service charge and listing fee will be refunded.

Non-Member Participation Fee: Canadian Resident non-CKC members competing with a wholly owned dog cannot win an award or title unless they pay a non-member participation fee or a membership fee to the CKC. The Canadian Resident Non-member Participation Fee is \$59.40 plus GST. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

Change of Entry: Change of Entry may be accepted, subject to the judging schedule and group limit.

FPOT&C may be offering a "Show 'n Go" on Friday evening, May 21, 2021. Details will be sent with judging schedules.

PLEASE NOTE THAT SMOKING IS PROHIBITED ON THE PROPERTY.

Rules Governing These Trials

1. A signed Covid-19 Waiver and declaration form is required and must be given to the secretary upon arrival.
2. Dogs must be kept under control at all times and on leash at all times with the exception of the judging ring.
3. Dogs are not allowed in the building.
4. Collars other than those specified in these rules are not allowed within the venue. Violation of this rule may result in removal of the dog from further competition at the trial.
5. Forbidden Plateau Obedience & Tracking Club will use all reasonable care to ensure the safety of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, loss or other misfortune to dogs, exhibitors or patrons. It is distinctly understood that the welfare and conduct of an exhibitor's child is to be the sole responsibility of the exhibitor.
6. If for any reason beyond the control of the Club, it is impossible to open or complete the trials no refund of entry fees will be made, except: -
If Public Health Covid-19 Orders make it impossible to open or complete the trials, refund of entry fees will be made, **service fees will not be included in refunds.**
7. Judges are not required to wait for dogs. It is the responsibility of each handler to be ready with his dog at ringside when required, without waiting to be called.
8. Eligibility to enter specific rally obedience classes is detailed in the Rally Obedience Trial Rules and Regulations. Entrants should ensure they are entered in the correct class. FPO&TC will not be held responsible for incorrect entries.
9. Every dog entered in an approved rally obedience trial must be one of the following: registered with the CKC; have an Event Registration, Performance Event, Canine Companion or Temporary Competition number; or, have a Miscellaneous Certification number if it belongs to a CKC listed breed.
10. Please keep the building and grounds clean. Please pick up after your dog.
