The club must reject an incomplete entry form and promptly return it to whoever submitted it, be it the owner, lessee, or authorized agent.

Tendering of a dishonoured cheque in payment of entry fees shall be considered non-payment and is an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club.

**ATTENTION: FOREIGN EXHIBITORS:** Covid-19 border restrictions may preclude U.S. entrants from participating. ### **Rules & Regulations**

It is the responsibility of each competitor to be familiar with and abide by the Canadian Kennel Club Obedience Trial Rules and Regulations, effective January 1, 2021, including the rule changes due to Covid-19. Both can be found on the CKC website, WWW.CKC.ca

**Discipline:** Forbidden Plateau Obedience & Tracking Club reserves the right to remove any person from these trials. The Trial Superintendent shall have full control of this event which will be governed by the Canadian Kennel Club rules. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a trial held under the CKC Obedience Trial Rules and Regulations, is not subject to indignities of any kind. The Obedience Trial Committee Superintendent shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**Females in Season:** When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian’s certificate, certifying that the bitch was in season within the 10 day period preceding the trial must reach the Trial Secretary on or before the date of the Trial. The entry fee, service charge and listing fee will be refunded.

**Non-Member Participation Fee:** Canadian Resident non-CKC members competing with a wholly owned dog cannot win an award or title unless they pay a non-member participation fee or a membership fee to the CKC. The Canadian Resident Non-member Participation Fee is \$59.40 plus GST. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

**Change of Entry:** A dog may be moved from one official class to another within the same trial. A dog that has fulfilled the requirements for a title in accordance with the CKC Obedience Trial Rules, may be moved to the next level of competition. The transfer must be submitted to the Trial Secretary on the appropriate form by the owner or handler AT LEAST THIRTY MINUTES PRIOR TO THE COMMENCEMENT OF THE TRIAL, schedule permitting.

**Rules Governing These Trials**

1. B.C. Vaccination Card showing Proof of full Vaccination against Covid-19, together with valid ID, must be presented for inspection in order to enter the building.
2. A signed Covid-19 Waiver and declaration form is required and must be given to the secretary upon arrival.
3. Dogs must be kept under control at all times and on leash at all times within the building with the exception of the obedience ring.
4. Collars other than those specified in these rules are not allowed within the venue. Violation of this rule may result in removal of the dog from further competition at the trial.
5. Forbidden Plateau Obedience & Tracking Club will use all reasonable care to ensure the safety of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, loss or other misfortune to dogs, exhibitors or patrons. It is distinctly understood that the welfare and conduct of an exhibitor's child is to be the sole responsibility of the exhibitor.
6. If for any reason, beyond the control of the Club, it is impossible to open or complete the trials no refund of entry fees will be made.
7. Judges are not required to wait for dogs. It is the responsibility of each handler to be ready with his dog at ringside when required, without waiting to be called.
8. Eligibility to enter specific rally obedience classes is detailed in the Rally Obedience Trial Rules and Regulations. Entrants should ensure they are entered in the correct class. FPO&TC will not be held responsible for incorrect entries.
9. Every dog entered in an approved obedience trial must be one of the following: registered with the CKC; have an Event Registration, Performance Event, Canine Companion or Temporary Competition number; or, have a Miscellaneous Certification number if it belongs to a CKC listed breed.
10. Please keep the building and grounds clean. Please pick up after your dog.

## COVID19 Obedience and Rally Rules General Guidelines

Clubs will follow all Federal, provincial and local health rules when holding a trial and the protocol will be detailed in the Premium List. Judges, officials, and handlers will abide by the rules specified

The following are allowable temporary changes to the Obedience rules and regulations that ***Forbidden Plateau Obedience & Tracking Club*** will opt to use during their **November 27th – 28<sup>th</sup>, 2021 Rally Obedience** event while operation under COVID restrictions (**B.C. Public Health Orders & Advisories; Stage 4 of the Restart Plan**) However any other changes to any other rule not mentioned here will not be allowed.

- Judges may wear a mask even if not required by the club
- The chair or table where the leash and other equipment is to be placed should be located at a convenient place determined by the judge but can be located in the ring or if not appropriate, just outside of the ring such that the handler can obtain the item without leaving the ring
- It is recommended that the club publish either in the premium list or judging schedule or both, the modified rules that it is adopting for their event.

## **RALLY OBEDIENCE TRIAL**

### **2 GENERAL RULES & REGULATIONS**

#### **2.3 Ring Stewards**

- 2.3.1 It shall be the sole duty of the ring stewards to assist the judge, only as instructed by the judge. Ring stewards must ensure that no persons except the Trial Superintendent, Trial Secretary, Judge, other ring stewards and those actually engaged in exhibiting a dog before the judge are permitted within the ring during judging. **Experienced stewards must be available and be solely responsible for course pulling, set up and changes.**

### **4 PREMIUM LIST, CATALOGUE & JUDGING SCHEDULE**

#### **4.1 Premium Lists**

4.1.3 The trial-giving club shall forward one copy of the premium list to each of the following: the CKC Head Office (Shows & Trials Division); the judges for the trials; the local CKC Director; and the local Obedience Representative. These are to be sent at the same time the premium list is released to exhibitors. received not less than 60 days prior to the date of the trial.

#### **4.3 Judging schedule**

- 4.3.2 The formula for the preparation of the judging schedule shall be based on the judging of a maximum of ~~15~~ **10** dogs per hour. A 10 –minute walk-through for each class level must be included in the scheduled judging times and **walk-through's may be extended by the**

**judge if required.** (A & B classes of each level judged by the same judge may be combined for walk-throughs.) **Walk through's will be limited to 5 exhibitors at a time who must observe 6' social distancing.** If a large class is scheduled, judges will allow an additional 10-minute walk-through every two hours for the next block of dogs to be judged in the class.

## **5 RIBBONS & PRIZES**

**5.1.3 The trial hosting club can determine how prizes and ribbons will be presented, mailing them to exhibitors will be allowed or having them available for exhibitors on a separate table for pick up, no awards will be presented in the ring.**

- Spectators (other handlers) may be allowed in designated area near the trial ring.
  - Sanitizing ring steward touch point will occur with a change of personnel
  - Sanitizing all touch points in the building will occur between the 2 trials
